SCOPE OF SERVICES

1.0 It is clearly understood by the parties that in respect of Services to be provided by Contractor under the Contract, responsibility of Owner shall be limited to provide gate pass for the vehicles & drivers and Contractor shall be responsible for providing all other Services required for providing vehicles as per this Technical Specification.

In this Technical Specification, capitalized terms used but not defined shall have the meaning assigned to them under the contract dated [•] (the "**Contract**").

2.0 GENERAL OBLIGATION OF THE CONTRACTOR

- 2.1 The Contractor shall obtain, at its expense, all Permits required to be obtained by the Contractor, to allow it to carry on its business and provide the Services under the Contract.
- 2.2 Pursuant to the Contract, the Owner is contracting for the Services of the Contractor, as an independent contractor, to provide vehicles in accordance with this technical specification of the Contract.

3.0 **SERVICES**

- 3.1 In furtherance of and without limiting the obligations and responsibilities of the Contractor specified in the Contract, the Contractor shall, at all times commencing from the Effective Date and continuing through the Term and in accordance with the provisions of the Contract, perform the services specified hereunder (the "Services"). For the convenience only, Services have been categorized. However, any Services envisaged under the Contract to be provided by Contractor, irrespective of their categorization, shall be provided as and when required.
- 3.2 The Contractor shall be required to provide commercial chauffeur driven car on monthly hire basis. The vehicle must be registered as commercial vehicle and should be new (not more than 12 months old from the date of registration) and should not have run more than 10,000 Km with well-maintained interiors & valid statutory permits/licenses for a three-year contract period from the date of award. Professional drivers having valid commercial licenses should only be provided. The minimum required technical specification of the car to provide on hire is detailed as under: -

- 3.2.1 Vehicle must be immaculate and in Road worthy & excellent running conditions.
- 3.2.2 Company fitted CNG vehicles (if and as applicable) shall be deployed by the contractor under this contract only with the approval of OTPC.
- 3.2.3 The vehicle must be with commercial registration & permit.
- 3.2.4 Contractor shall provide vehicles registered in the name of the Contractor as per minimum quantity specified below:

Package 1: minimum 2 (two) nos. vehicles shall be owned by the Contractor Package 2: minimum 1 (one) no. vehicle shall be owned by the Contractor minimum 1 (one) no. vehicle shall be owned by the Contractor

- 3.2.5 For balance vehicles, Contractor should have bilateral agreement between Contractor and Vehicle Owner for such deployment.
- 3.2.6 **Measurement of the job & Working Time**:

The following methods of measuring the job carried out by the Contractor will be adopted:

- 3.2.6.1 Half Day shall mean a period of 4 hours from the scheduled time of report on week days / working days.
- 3.2.6.2 Full Day shall mean a period of 8 hours from the scheduled time of report.
- 3.2.6.3 Holiday / Leave for Vehicle: Leave may be allowed on any one day during the month with two days' prior written consent of officer in charge for the purpose of routine maintenance of the vehicle.
- 3.2.6.4 Even if no holiday is availed by the Contractor, no further compensation shall be given in lieu of such working on holidays/off days.
- 3.2.6.5 OTPC shall allow actual running to and fro from (any place agreed by OTPC administration) to place of duty limited to 10 KMs per day.
- 3.2.6.6 Day means calendar day and Month means Calendar Month.
- 3.2.6.7 The vehicles as above will be required for all days of the month.

- 3.2.6.8 The vehicles on monthly hiring basis will be required for minimum continuous 24 hours duty per day.
- 3.2.6.9 Working time for the vehicles shall be intimated by the Officer In-charge of HR Department. Normally the working hours shall start at 08-00 Hrs.
- 3.2.6.10 In case the reporting time of the vehicles is informed specifically other than normal reporting time, such time of reporting shall be reckoned for calculation of 24 hours on the that day.
- 3.2.7 Parking and Reporting Place:
- 3.2.7.1 All Vehicles on 24 hrs x 7 days/week basis shall be parked inside Palatana Plant or at OTPC Township.
- 3.2.7.2 Reporting place in the plant shall normally be Admin Building, OTPC Plant premises, Palatana, Udaipur, Tripura -799105. In case of change of reporting place on any day shall be intimated to the Contractor or Chauffeur telephonically in advance.
- 3.2.7.3 In case breakdown of vehicles at any point of time during the contractual period, replacement of equivalent or higher class of vehicle is to be made immediately within an hour by the Contractor without fail.

4.0 **Contractual obligation of the Contractor:**

4.1 OTPC will give instructions to the Contractor or his authorized representative only. OTPC will have nothing to do or be concerned with the employment of employees working for the Contractor. The relationship between OTPC and the Contractor will be that of independent entities and nothing herein contained will amount to joint venture, partnership or an employer –employee relationship.

5.0 Towards selection, control and supervision of employees :

- 5.1 Contractor shall decide the number of employees to be deployed for execution of the work awarded to him and he or his authorized representative will be solely entitled to dictate such workers about the manner of carrying out the work as per the prescribed specifications and quality plan.
- 5.2 Contractor shall employ local people from Tripura as drivers.
- 5.3 Contractor shall supervise the work allotted to him and to be carried out by their employees.
- Contractor to ensure that the employees deployed in the premises of OTPC are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification, experience etc. The Contractor shall arrange to obtain police verification of each of chauffeur/driver deployed.
- 5.5 The Contractor shall provide road safety refresher training to their drivers once per year.
- 5.6 The Contractor should also ensure that he /she will engage the vehicles with chauffeurs/drivers who know the following genuine ethics and he /she will instruct them to implement the same.
- 5.7 Chauffeur/driver provided for such vehicle(s) shall maintain logbook for recording relevant journey details and must be holding professional valid driving license for commercial vehicles with sufficient experience for minor repair of vehicles and attend to break downs and have adequate knowledge of reading, writing and speaking English/Hindi/Bengali. The chauffeurs

should be well conversant with the roads and streets of Agartala, Udaipur, Palatana and other surrounding areas. He must have experience in driving on highways. Required tool box must be provided with each vehicle by the Contractor. 5.8 The chauffeur/driver should have minimum three years' experience of driving similar vehicle with proof of valid commercial driving license. 5.9 The chauffeur/driver should keep the vehicle neat and clean daily / timely before reporting for the duty. 5.10 The chauffeur/driver should allow the passengers to get inside the vehicle and later on he should enter into vehicle. 5.11 The chauffeur/driver himself should open and close the doors for the passengers / customers while getting into and getting out of the vehicle. 5.12 The chauffeur/driver shall not smoke/be drunken while on duty. 5.13 Contractor to maintain appropriate records of these employees/drivers deployed to carry out the job(s). 5.14 Contractor should issue appropriate appointment letters to his employees/drivers. 5.15 Contractor to provide employment card/identity card with photographs duly verified and attested by the Contractor to his employees/drivers. Contractor to indicate the name of the proprietary/partnership firm/company, place of work, contract number and duration of validity of card. 5.16 Contractor shall provide mobile phone to the employees/chauffeur/driver deployed by him for operation of vehicle. 5.17 Contractor shall provide common mobile no for each 24hr vehicle (Irrespective of change of Driver) 5.18 Contractor will be responsible for the conduct of his employees/driver. In case of any misconduct/misbehavior by any employee/driver, the Contractor will replace such employee(s)/drivers immediately. 5.19 Contractor will keep watch on his employees/drivers and he will be liable for any pilferage/loss to OTPC due to acts of omission and commission by his employees/drivers. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees/drivers deployed by the Contractor shall lie exclusively with the Contractor. 5.20 The Contractor shall be responsible for enforcing all safety regulations as applicable under motor vehicle act 1988 and Motor Vehicle Amendment Act 2019 including subsequent amendments notified if any. 5.21 The Contractor to ensure that all precautions are taken for safety of his employees/drivers and Vehicles. 5.22 In the event of termination of contract for any reason, whatsoever, the Contractor shall withdraw all his employees/drivers from the establishment of OTPC. In case, Contractor decides to terminate services of his employees/drivers, he should settle all terminal dues including retrenchment compensation.



5.23 The Contractor shall maintain sufficient funds with the chauffeurs/drivers to meet any emergency requirement on account of fuel, parking fees, emergency repair/maintenance etc.

6.0 **Legal obligation of the Contractor:**

- 6.1 All statutory requirements under Minimum Wages Act, 1948, Payment of Wages Act, 1936, Workmen Compensation Act, 1923, EPF & MP Act, 1952, payment of Gratuity Act, 1972, ESI Act, 1948, Contract Labour (R & A), Act, 1970, Payment of Bonus Act, 1965, Income Tax, Service Tax Act, Motor Vehicle Act, 1988, Motor Vehicle Amendment Act, 2019 and all other applicable Acts shall be complied by the Contractor.
- 6.2 Contractor shall ensure payment of HRA (presently @Rs.1300/- per month) should be given to the Drivers staying beyond 8 Km from plant Premises, in the scope as notified by Labour dept, GoT time to time.
- 6.3 Contractor shall comply with all statutory requirements, rules, regulations, notifications in relation to employment of his employees/drivers issued from time to time by the concerned authorities.
- Contractor shall ensure payment of statutory prescribed minimum wages as applicable at Palatana issued by GoT time to time. The Contractor shall maintain proper records of timely disbursement of wages as per Payment of Wage Act, 1936. These records need to be preserved for a period of at least 3 years and should be made available even after the contract is over for any verification by the statutory authorities/ OTPC authorities.
- The Contractor shall indemnify OTPC against all claims and losses under various labour laws, statutes or any civil or criminal law in connection with employees/drivers deployed by him.
- The liability for any compensation on account of injury sustained by an employee/driver of the Contractor will be solely attributable to the Contractor.
- 6.7 Route permit / national permit / clearance form RTO or any other authority concerned and compliance of any other legal formalities connected with the contract have to be arranged by the Contractor at his cost. OTPC does not take any responsibility in this regard.
- The Contractor will ensure that all vehicles deployed under this contract agreement are covered by a comprehensive insurance policy. Under no circumstance shall OTPC be liable to compensate for any loss or damage that may be caused to / by the vehicles while engaged in discharge of the Contractor's obligations under this contract.
- 6.9 Contractor to obtain insurance cover for his employees/ vehicles/tools and tackles etc. and take risk insurance coverage at his own cost. OTPC shall not be responsible for any loss, damage, pilferage of his property and / or his employees/drivers.
- 6.10 OTPC shall not be held liable for any incident occurring after the release of vehicle/driver from duty or when the vehicle is moving without any authorized OTPC official.
- 6.11 The driver should abide by the rules laid down by Transport Authority or any Authority relevant to the subject and should always strictly follow the traffic rules and Regulations so as to ensure safety of the passenger. OTPC will not be responsible for any Challan/Penalty by Traffic Police.

6.12 Towards Supply of vehicles and log books:

6.12.1 Contractor shall submit to OTPC within 7 days of LOA as defined in the Contract (a) key manpower and the mobilization plan for vehicles to be deployed as per list of vehicles



- indicated in clause no. 3.2 of this technical specification (b) documentary evidence (RC, Insurance, PUC) for vehicles owned by the bidder to be deployed by the Contractor(c) Agreement with the owners of the vehicles to be hired by the Contractor (d) plan for statutory compliance with timelines in line with the Contract and technical specification.
- 6.12.2 Well maintained and road worthy vehicle will only be taken in the service of OTPC. The supplied vehicles will be inspected by Admin in-charge or other person authorized by OTPC and if the vehicle are not found in road worthy/good condition, the same will have to be made properly maintained within reasonable time.
- 6.13 The vehicle will be utilized by OTPC, Palatana for plying in Tripura and adjoining states etc.
- 6.14 The vehicle should be furnished with following items.
- 6.14.1 The relevant valid documents like R.C Book, Driving License, Permit and Insurance policy, pollution certificate, etc.
- 6.14.2 The Contractor shall comply with following Road Safety Requirements:
 - (a) Spark Arrestors
 - (b) Seat belts
 - (c) Maximum speed limit of 20 kmph within plant premises and 60 kmph outside the Plant.
 - (d) Use of indicators before taking turns
 - (e) Car-reversing horn.
 - (f) Valid portable fire extinguisher
 - (g) Foot matting need to be replaced once in every Six months or in case of any wear & tear.
 - (h) Car freshener, Tissue paper box, Mobile charger, water bottle & other minimum amenities.
 - (i) Sanitizer and first aid box as per the list to be provided by OHC,OTPC
 - (J) Safety shoes of reputed brands like liberty, Vikram, Karam etc. for all drivers at all the time.
 - (k) Safety policy of OTPC to be adhered as per norms attached at Annexure -1 to this technical specification.
- 6.15 Condition of tyres should be new. No retreaded tyre should be allowed to be used. New standby tyre should be available in each vehicle. Tyre should be replaced after maximum 50000 KM running of the vehicle and in case of any wear & tear of tyre. In case, Contractor doesn't replace the tyre within 7 days of running more than 50,000 Kms, OTPC shall get the tyres replaced and recover the cost from the Contractor.
- 6.16 The vehicle should be provided with OTPC Gate Pass issued by HR& Admin department of OTPC and it should be displayed on the front windshield.
- 6.17 The vehicle must be fueled adequately for daily run.
- 6.18 Contractor shall provide large size premium quality Bombay Dyeing towel as a seat cover (preferably white colour) which needs to be washed weekly and replaced in every six month or as & when requirement basis. Vehicles should be provided with car freshener of good qualities, mosquito repellent & one litre water bottle in every day. Vehicles should be provided with mobile charging facility.



- The vehicle should be provided with additional/emergency accessories like (i) Fan belt, (ii) Spare Wheel, (iii) Standard tool kit, (iv) spare bulb, (v) fuses, (vi) hose pipe etc. to attend emergency repairs, (vii) Torch, (viii) Umbrella etc, the cost of which is included in the Contract Price.
- 6.20 **GPS shall be installed in all vehicles**. Mileage Meter (KM Indicator Meter) reading should be in properly working condition/sealed. If KM Indicator and GPS of any vehicle is found tampered at any point of time, OTPC reserves the right to terminate the Contract without any notice.
- Log book should be maintained with vehicle by the Driver reflecting journey undertaken daily which will invariably get filled up by the user himself in all cases affixing his signature and the same duly certified by the HR & Admin supervisor (authorized representative of OTPC). The daily trip / run details for billing shall be prepared on the basis of this. The actual kilometers travelled should tally with the GPS totalizer and should be attached along with the GPS screenshot/print along with the invoice. Payment shall be released after physical verification of KM reading through both vehicle odometer and GPS metering device. Maximum variation of 2% shall be allowed between the two readings. In case of more deviation, the lower of 2 readings shall be considered as for payment processing.
- 6.22 Chauffeur/Driver should be provided with proper uniform preferably white in colour and a mobile phone by the Contractor at his own cost.
- 6.23 In case of any accident involving the vehicle provided to OTPC, all liabilities whatsoever on account of any loss or damage to any person or property is incurred, the same shall be borne solely by the Contractor himself and OTPC in no circumstance shall be held responsible for same.

7.0 Rights and obligations of OTPC

- 7.1 In case the Contractor does not carry out the contractual/ statutory obligations or the services rendered by him are found to be unsatisfactory, OTPC shall bring the same to his notice and he will be obliged to discharge the obligations and rectify the deficiency / anomaly within specified time failing which OTPC reserves the right to impose the specified penalty and / or terminate the contract without assigning any reason whatsoever. In such an event, no damages will be payable for short closure of the contract.
- 7.2 OTPC reserves the right to terminate the Contract at any time without paying compensation whatsoever to the contractor in case of misbehavior, disobedience, dishonesty, insolvency, any court order, non-sanction of road permit or any other related activities on their part or their failure to fulfill their obligation under the contract.
- 7.3 OTPC reserves right to short close the contract at its discretion at any point of time without assigning any reason thereof.
- 7.4 OTPC reserves the right to check the Mileage Meter (KM Indicator Meter) and may get it calibrated.
- 7.5 OTPC reserves the right to ask for Replacement of Vehicle.
- 7.6 OTPC reserves the right to terminate the Contract incase Contractor fails to increase the ownership of vehicles to below mentioned numbers within the 3 months from the date of Award of Contract.
 - Package 1: minimum 2 (two) nos. vehicles shall be owned by the Contractor

Package 2: minimum 1 (one) no. vehicle shall be owned by the Contractor minimum 1 (one) no. vehicle shall be owned by the Contractor

8.0 Charges for default in Services

8.1 Following charges shall be levied for non-compliance to provision of Contract:

- 8.2 In the event of any breakdown, alternative arrangement of same model or latest model of vehicle should be made available by Contractor immediately at his own cost failing which action as clause 8.1(1) shall be applicable.
- 8.3 While on duty, if the chauffeur of the hired vehicle is found to be indulging in any case of disobedience, misbehavior, malpractice, fraud or any act of misdemeanor, a penalty will be as per clause no. 8.1 (3) imposed on the concerned Contractor. A repeated act of indiscipline is punishable by stopping the services with any notice or termination of the contract and other consequence depending upon the gravity of the case.
- 8.4 The decision of OTPC regarding interpretation of any terms and conditions set forth in the agreement shall be final and binding on the Contractor.

9.0 **Duration of the contract**

- 9.1 The duration of this contract will be for a period of Three (03) years with effect from the date of its commencement. The contract may be extended after completion of first and second year of services at the same rates and terms and conditions depending upon satisfactory performance certified by OTPC-Plant administration.
- 9.2 Extension of contract cannot be claimed as a matter of right by the Contractor and the decision of OTPC shall be final and binding on the Contractor in this regard.
- 9.3 Successful Contractor shall arrange to mobilize as per instruction from concerned OTPC official of HR & Admin dept. after awarding of LOA/ Work Order.

10.0 **Special Terms and Conditions of Contract :-**

- 10.1 **Statutory Compliances :** Contractor shall also be solely responsible for the payment of all benefits to the Contractor Staff under Applicable Law and rules, State Govt Notification etc, such as provident fund, bonus, overtime payment, ESIC/ECA insurance ,OT,retrenchment compensation, leave, etc., and shall keep the Owner indemnified in this regard against any claims.
- 10.2 **Vehicle condition (Induction Clause):** Vehicles running KMs should be less than 10000 KM and not older than 12 months from the date of registration. Both conditions are mandatory. The vehicle must have commercial registration/permit/insurance/ PUC/Fitness etc. as per MV Act and rules.
- Vehicle condition (Exit Clause): Vehicles may be replaced after 80000 KM of running meter or it may be continued maximum up to 100000 KM of running meter if found under satisfactory condition and older than 36 months from the date of registration or whichever is earlier. However, if vehicle condition is found not satisfactory within said contract period by way of wear & tear, accidental damage, mechanical failure, violation of MV Act / rules or amended time to time then agency has to replace the vehicle as per standard terms and conditions. In case, Contractor doesn't replace the vehicle even after running 100,000 kilometers and upto 125,000 Kilometers, the rental shall be reduced to 85% of the Monthly Rental Price. In case the Contractor doesn't replaces the vehicle even after running 1,25,000 Kms, the rental shall be reduced to 70% of the Monthly Rental Price.
- 10.4 To coordinate with various drivers and other related works a single point contact with escalation matrix should be shared with OTPC for 24 x 7 support.
- 10.5 Ambulance will be duly fitted with medical facilities/equipment such as Oxygen supply system (Oxygen Cylinder with mask) stretcher and first aid box etc along with standard medical equipment.
- 10.6 All drivers to be provided with minimum two sets of good quality /branded uniform in a year with CONTRACTOR LOGO/BRAND on each uniform and on each vehicle for identification (Vehicles and drivers are employed by and under Contractor).
- 10.7 Medical test for each driver to be done mandatorily prior to joining of duty and to be repeated on yearly basis by the Contractor and reports to be submitted to Medical Officer of OHC at the start of every year of contract period.
- Duty hours of drivers shall normally be 8 hours per day. Monthly rental includes 24 hours' rate of vehicle & up to 12 hours drivers rate. Contractor shall be responsible for making any

	overtime payment for providing Services under this Contract and Owner shall not bear any liability whatsoever in this regard.
10.9	For 24hr duty vehicles, 3 drivers are required @ 8 hours duty per day.
10.10	Leave reliever for driver duty on Sundays/Weekly off (as per Roaster) /holidays/Leave etc shall be provided and is under Contractor scope.
10.11	For security reasons, the vehicles shall be parked inside the OTPC Township parking area (or any other area specified by OTPC Administration) after completion of duty hours.
10.12	Vehicles deployed against the contract shall be for exclusive use of OTPC only during the term of contract.
10.13	Local conveyance (To & Fro) from residence of drivers to OTPC Township, Khilpara / OTPC Plant, palatana will be in the scope of Contractor.
10.14	Contractors are liable to comply all statutory compliances applicable for OTPC Palatana plant and in case of any non-compliance, then OTPC has the right to make the compliances on behalf of the contractor and 20% overhead charges will be deducted from contractor's RA bills.
10.15	Contractor to consult and take consent of company authorized officer to replace his driver (his contract staff).
10.16	In case of unavoidable situations/strike/ agitation etc. at OTPC plant, Contractor to provide four (4) nos. vehicles outside the plant gate to facilitate the movement of employees from plant gate to Udaipur/Agartala etc.
10.17	Contractor to submit the duly signed checklist along with the monthly bill. Driver payment/ statutory compliances cannot be linked with the release of payments against monthly RA bills. Contractor bills shall only be processed upon receiving of all required check listed documents along with monthly bill.
10.18	In order to meet the exigency requirements like RTA fine, flat tyre, parking charges, misc expenses etc, min. amount of Rs.500/- in cash shall be made available by Contractor with all the drivers at every point of time. OTPC will carry out the sudden inspection to verify if the drivers are carrying this amount.
10.19	Incase Contractor does not comply to the provisions of technical specifications and the Contract including supply of items and maintenance of deployed vehicles, OTPC will procure the required items / service by its own and deduct the amount with 30% overhead charges from R.A bill of the contractor.
10.20	Police verification Reports of drivers is must and shall be submitted to OTPC before reporting at duty.
10.21	A common mobile handset with SIM and full recharge to be kept with each 24 hours shift vehicles by the Contractor 24X7.
10.22	Organizing motor vehicle training to the drivers at least every 6 months.
10.23	All the vehicles need to be fueled adequately all the time. 24 hours shift vehicles should be fueled with FULL TANK at least once per day.
