

<u>Instructions for filling up Price Schedule (Form 1-A, 1-B & 1-C)</u>

- The total lump-sum price as quoted in Form 1-A of the Bidding Document shall include the
 cost of supply, services, taxes and duties respectively as included in the scope of supply and
 services as stipulated in the Bidding Document and to complete the scope of supply and
 services contemplated by the Bidding Document irrespective of whether all the items for
 supply and services are categorically listed out/brought out elsewhere or not.
- 2. Unless additional requirements are made (not contemplated by the Bidding Document), total payments to be made to the Bidder shall be limited to quoted Price.
- 3. Obligation of the Bidder under the Contracts is not limited to the quantities that the Bidder may indicate in the schedule of break-up of prices in its Bid (in Form 1-B). Bidder shall carry out entire scope of supply and services as specified in Bidding Document within the quoted lump sum price as included in schedule of prices under Form 1-A in the Bid.
- 4. Prices quoted by the Bidder shall also include cost of any other services not specifically mentioned in the Bidding Document but necessary for fulfilment of bidders obligation and completion of Services.
- 5. All indirect taxes, duties and levies (such as goods and service tax, local taxes etc.) as applicable (in India) on a direct transaction between the Owner and the Supplier (both present and future) shall be borne by the Owner.
- 6. Price shall be quoted both in figures as well as in words in clear legible writing. In case of a discrepancy between the amount stated in figures and words, the amount quoted in words shall prevail.
- 7. The total prices shall be fixed till the expiry of term of the Contracts and shall not be subject to price variations.
- 8. Capitalised terms used in this Form but not defined shall have the meaning prescribed to them under the Bidding Document.
- 9. Bidder shall specify name of the company and sign and affix company seal on all pages of Price Bid.
